Results Submission Form Instructions

Entry 1: Test ID is assigned by the 1394TA after the results form is submitted. The ID is used to correlate results/information about the specific product being tested.

Entry 2: Company ID is assigned by the 1394TA when the logo license agreement is signed. This ID is used to correlate all information submitted by Company.

Entry 3: 1394TA Member (Yes or No) indicates whether or not Company is a 1394TA member. Self-Test companies must be 1394TA members.

Entry 4: Name of Company whose product results are being submitted. This name will be published on the 1394 Trade Association website therefore the most complete name should be used.

Entry 5: Name of Contact for Company.

Entry 6: Phone number of Contact.

Entry 7: Address of Contact.

Entry 8: Email address of Contact.

Entry 9: Descriptive name of the product. This name will be used on the 1394TA website to describe the product therefore COMPANY should use the most appropriate description for this product. (Example: DVHS – VCR with “feature xyz”, HDD – External HDD with automatic back-up, etc...)

Entry 10: Model number of product. This model number will be published on the 1394 Trade Association website therefore the most complete model number should be used.

Entry 11: Provide the Product Category type of the product whose results are being submitted. Please see Product Category list for details. This Product Category will be published on the 1394 Trade Association website therefore the correct Product Category shall be used.

Entry 12: (Optional) List the make and model number of each unique cable type sold with the product. This information will be used to determine if the 1394TA Compliance Logo Program has certified the cable(s) used.

Entry 13: Please provide the 1394TA assigned Certified Laboratory #. If a Self-Tester then the Certified Laboratory # and Company ID will be the same.

Entry 14: If the product was tested by a Self-Test, or Third-Party Certified Laboratory, please list each device used in the Private Plugfest replacement test. Please see the specific Private Plugfest replacement test for your specific product category.

Entry 15: Please list each device used in the Network Test Suite test. For details please see the specific Network Test suite test for your specific product category.
